## TERMS AND CONDITIONS OF SALE OF GOODS

### **1 CONTRACT**

- 1.1. These terms and conditions of sale of goods ("Contract") apply to all goods supplied by FUTURE TIDE INVESTMENTS.
- 1.2. All references to "Customer" refer to the person or juristic person who the products are marketed or supplied to by FUTURE TIDE INVESTMENTS, including Dealers and Retail Customers.
- 1.3. This Contract will come into force between the Customer and FUTURE TIDE INVESTMENTS for the sale of any goods when FUTURE TIDE INVESTMENTS has –
  - 1.3.1 Received the Customer's order for the goods and
  - 1.3.2 Accepted the Order by issuing the Customer with a proforma invoice ("Proforma Invoice") or in the case where no Proforma Invoice is issued, a tax invoice ("Tax Invoice").
- 1.4. Once the above requirements have been met, there is a legally binding contract between the parties.

### **2. DEALER AND RETAIL CUSTOMERS**

- 2.1 Customers who have applied and been accepted as registered dealers for FUTURE TIDE INVESTMENTS will receive dealer prices.
- 2.2 All Customers who are not Dealers are considered to be retail Customers and retail prices will apply.

### **3 PRICES AND AVAILABILITY OF GOODS**

- 3.1 All prices displayed are Dealer Prices
- 3.2 Dealer pricing applies only to Registered Dealer customers
- 3.3 All prices are exclusive of delivery charges.
- 3.4 The images of the Goods on the Website are for illustrative purposes only and may differ from the actual Goods.
- 3.5 The price payable by the Customer will be the price as at the date of the Invoice, this price may differ to the price on the Website or Quotation due to the fluctuation in the exchange rate.

#### **4 PAYMENT**

- 4.1 Payment terms are strictly cash on delivery ("COD") unless a separate payment plan has been agreed with by Management.
- 4.2 Payment can be made by electronic funds transfer ("EFT") directly into FUTURE TIDE INVESTMENTS bank account, details to be supplied upon request. Cash will only be accepted in store. Swipe facility is available in FUTURE TIDE INVESTMENTS Offices
- 4.3 FUTURE TIDE INVESTMENTS will provide the Customer with an Invoice upon delivery of the Goods.

#### **5 DELIVERY**

- 5.1 Goods will only be released once payment has been received and confirmed by FUTURE TIDE INVESTMENTS
- 5.2 Any Invoice signed by the Customer and/or its authorised representative and/or its nominated agent and held by FUTURE TIDE INVESTMENTS, shall be prima facie proof that delivery was made to the Customer.
- 5.3 The Customer must inspect the Goods on receipt and be satisfied that the Goods conform in all respects to the quality and quantity ordered and are free from any defects, following which customer is required to sign two copies of goods receipt voucher (GRV).
- 5.4 The Customer may elect to instruct their own courier service for collection of the Goods and pay that courier directly.
- 5.5 All risk in the goods passes to the Customer when the Customer collects the goods from FUTURE TIDE INVESTMENTS. Should the Customer elect to use the preferred courier, FUTURE TIDE INVESTMENTS shall not be liable for any damage to or loss of the goods once they leave the premises of FUTURE TIDE INVESTMENTS. All risk in the goods passes to the Customer once handed over to the preferred third party courier. An invoice, signed by the courier shall be proof that the order was collected by the courier on behalf of the Customer. The Customer hereby indemnifies FUTURE TIDE INVESTMENTS from any claims of any nature whatsoever that might arise from engaging the preferred courier's services, unless such claim arises as a result of gross negligence on the part of FUTURE TIDE INVESTMENTS
- 5.6 Ownership in all Goods sold and delivered shall remain vested in FUTURE TIDE INVESTMENTS until the full purchase price has been paid.

#### **6. RETURN OF GOODS**

Goods should be checked and verified before signing (GRV), beyond this, no returns will be accepted.
